


Committee for Melbourne members' survey: priorities for shaping Melbourne's future in a State election year


1. Key findings



Q1 Key point summary concerning progress on 4 key areas for Melbourne's progress:

While some progress has been made in addressing 4 key areas for Melbourne's future – Future Economy, Urban Optimisation, Infrastructure and Liveability – respondents were clear that more needs to be done in all areas.

These results – where a minority of members believe Melbourne is making sufficient progress against these key areas – supports the Committee's objective to pursue them as critical drivers of Melbourne's future economic and social wellbeing.



Q2 Key point summary on highest priorities for the Committee in the lead up to the Victorian election:

While the provision of an integrated transport plan stood out as the highest priority at 95%, the other top priority actions were relatively diverse, and reflected an awareness of the discrete, and yet connected, relationships between the tangible and the social infrastructure required to meet Melbourne’s future challenges.

The Committee has called for an integrated transport system for Melbourne for a number of years. We will invite the government to brief our members on current transport policy at the earliest opportunity.

Q3 Key point summary on the highest ranked priorities for the Committee to address:

The highest priority for action is the provision of an integrated transport plan, with 71% citing it as one of the most important actions – when all actions are prioritised against each other.

This in an environment where the state and federal governments are spending billions of dollars on transport infrastructure and in a period where Melbourne is expanding by the population of Ballarat or Bendigo every year, and by a combined Ballarat, Bendigo and Geelong every four years.

This demonstrates that our members – while welcoming of the investment in transport infrastructure – understand that the jigsaw needs to be put together in a particular way if Melbourne is going to receive the full benefit from these assets.

Q4 Key point summary on other priorities:

There was a focus on ensuring Melbourne becomes a leading city that tackles issues associated with climate change and efficient waste disposal.

There was also a focus on the need to assist the vulnerable members of society, including the homeless.

Other points included:

- Education for disadvantaged and the West of Melbourne
- Recognising and promoting the importance of arts & culture to the fabric of the city
- Less onerous planning controls

- D) Liveability: Continue to be a world-leading liveable city with exceptional healthcare and education services, strong sport, recreation, arts and cultural sectors with access and opportunity for all residents.
